## REGISTRATION FORM (1.08.2021)

### **GUIDELINE FOR AUTHORS (1.08.2021)**

Microsoft Word format (.doc or .docx), Times New Roman, font size 14, spacing 2.0. Margins: top, bottom, right - 2.0 cm, left - 2.5 cm. The article will begin with the TITLE (capitalized) and the authors (full name, professional and scientific titles, name of the institution, city and country). In order to facilitate the identification of author and institution, Arabic numerals will be used in the upper (superscript) index, placed in front of the author's and the institution name (eg: <sup>1</sup>Baciu... <sup>1</sup>Institution...). No more than 4 authors are recommended.

Papers must have an abstract in English and the following sections: introduction, material and methods, results, discussions, conclusions, bibliography. The text volume (including the bibliography) will not exceed 11 pages for a general paper, 10 pages for an original research, 5 pages for a case presentation. The size of a figure or a table will not exceed ½ of A4 page, the total number of tables and figures will be less than ½ of the number of pages. Images must have a high quality.

Bibliographic references will be numbered using Arabic numerals in the alphabetical order of the first author and will be included in text in square brackets [1]. Bibliographic references must include: authors (name and initial of the first name), title of the cited article (in the original language), journal (international abbreviation), year of publication, volume, number of pages. Ex.: 1. Devaney E.J., *Esophagectomy for achalasia: poticni selection and clinical experience. Ann. Thorac. Surg.*, 2001; 72(3):854-8.

Each paper must be accompanied by **two peer reviews**. Papers must comply with the anti-plagiarism principle. Materials published in other medical editions will not be accepted for publication. Articles should have a UDC code. Authors are responsible for the linguistic accuracy of their papers. Organizing board is not responsible for the veracity of the published materials. Papers that do not meet the requirements will be rejected.

Uploaded WORD document with the paper text will be named as follows: <Name of the first author> – <2-3 keywords from the paper title> (ex.: „Pădure – Family violence.docx”). Uploaded PDF files with scanned signed reviews will have the same name with the uploaded WORD file, followed by “– R1” or “– R2” respectively (ex.: „Pădure – Family violence – R1.pdf”).
